It is a standardized set of 200 multiple-choice questions (covers all seven legal practice areas: constitutional law, real property, criminal law and procedure, civil procedure, evidence, contracts, and torts) usually taken on the first day of the state bar examination.

The MBE has 200 hypothetical multiple choice questions.

Each part has 10 essay questions. The pass mark is 50. The parts 1-2 are usually taken in October and the rest are usually taken in March. One does not need to pass all four parts in one year.
